Homebound Meal Delivery: Meals On Wheels of Tampa's (MOWT) mission is "to nourish, enrich and strengthen the lives of seniors (62 and older) and individuals who have difficulty leaving their homes and are challenged to prepare meals". The delivery of daily hot meals by caring and trusted volunteers gives seniors and homebound citizens the opportunity to age in place with consistent balanced nutrition, dignity, safety, and independence. During fiscal year 2025, approximately 262,000 meals were delivered through our Homebound Meal Delivery program to more than 1,186 recipients. All meals are produced daily by professional staff in the MOWT commercial kitchen. We offer 3 menus to select from: Heart Healthy, Diabetic Friendly, and Renal Friendly. MOWT is meeting the specific dietary needs of the fastest

Social connection is effective in making a profound difference in the lives of older adults and homebound citizens. A daily knock on the door from a MOWT volunteer bringing a hot meal, offering encouraging words and a vital safety check on isolated neighbors, is a crucial ingredient in the powerful impact of this mission. Volunteers are the heart and soul of MOWT. The volunteer is often the only person the recipient will talk to during the day. In FY 2025, 1,879 volunteers generously donated their time, vehicles, fuel, and compassion to improve the lives, outlook, and well-being of our recipients. Their gift of service allows us to deliver at an affordable price and provides the crucial social connection that means

The encouraging words from volunteers, provides enrichment for the soul. For many of the homebound, a visit from a volunteer is the only human contact they will receive that day. Together we strengthen the community by caring for a segment of our population who are often forgotten and can not get out of the house.

growing segment of the community, our seniors, many of whom require healthy food delivered to their doorstep, at an affordable price, to age in place. No one is ever turned away from service due to an inability to pay for their meals. As a privately funded organization, community contributions and earned income from MOWT's social enterprise address this funding gap. In FY 2025, Meals On Wheels of Tampa's commercial kitchen produced over 621,000 meals that were distributed in the Tampa Bay Area in support of our mission.

The Executive Director completes an annual performance evaluation of all staff in June/July. An amount for anticipated salary adjustments is estimated during budget planning in May for the upcoming fiscal year (beginning July 1). This amount is arrived at with input from the Executive Committee, review of comparable data, and reviewing current economic factors. The Executive Committee is responsible for Executive Director's annual salary adjustment, and the Executive Director has responsibility for awarding all other staff salary adjustments. Salary adjustments are included in the 7/31 pay date (encompassing the 7/1 - 7/15 pay period).

Prior to the end of the fiscal year, the Executive Committee meets to discuss the current year's performance and determine whether an annual bonus is warranted to the Executive Director and staff. If an annual bonus is awarded, the Executive Committee determines the Executive Director bonus and determines a staff "bonus pool". It is the responsibility of the Executive Director to distribute the "bonus pool" to staff as he deems appropriate based on performance throughout the fiscal year.
